In re NFL Players Concussion Injury Litigation - MDL-2323 / Case Summary

In early 2012 retired professional football players throughout the Country brought a class action against the

National Football League for hiding the dangers of concussions. Those repetitive blows to the head have resulted in hundreds of retired players committing suicide, as well as thousands diagnosed with Dementia, Alzheimer's, ALS, and Parkinson's disease.

U.S. federal Judge approved a settlement in the NFL concussion matter. That litigation has become known as *A The National Football League Players Concussion Injury Litigation*. The billion-dollar settlement allowed the NFL to avoid a trial in the class action that could have cost the league multiples of that number.



In re NFL Players Concussion Injury Litigation - MDL-2323 / Case Summary

In negotiating the Settlement, the lead attorney appointed by the Court agreed on behalf of the 21,000 retired players alive to release the NFL from all liability arising from concussions forever. Most notably, the release included language that precludes a retired player from ever suing the league, let alone for injuries arising from chronic traumatic encephalopathy, more commonly known as CTE.

This debilitating disease causes neurological changes in the brain, so progressive that an astonishing number of retired players have taken their own lives. Thousands of others have been medically diagnosed with moderate to severe Dementia, Alzheimer's, ALS, and Parkinson's.

The deaths and the diagnoses continue.

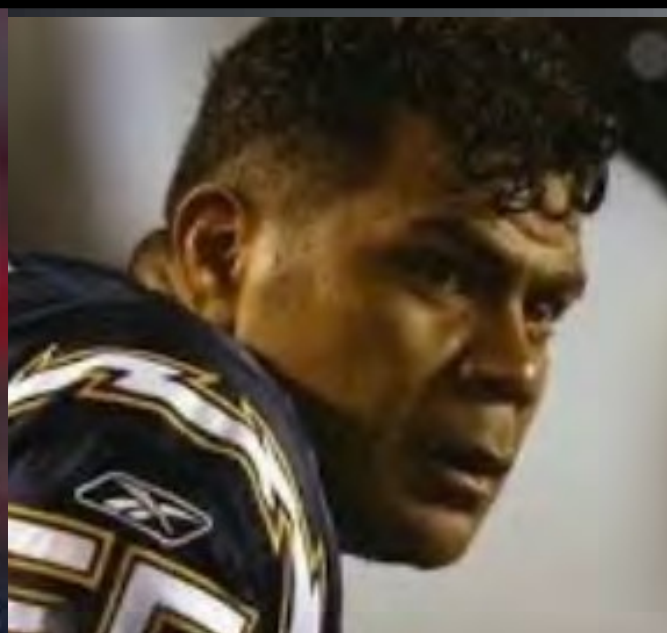
